58. Public Forum (A maximum of 10 minutes is allowed for this item)

Robert Forbes of Acton Bridge Parish Council drew attention to the problem of speeding vehicles along a section of Station Road/Gorstage Lane within Acton Bridge and outlined surveys carried out by the Council which demonstrated an alarming incidence of vehicles travelling well in excess of the speed limit for the road. He also described measures taken to address the problem i.e. speed detectors and new signage. He requested assistance from Weaverham Parish Council to help address the problem as the road in question straddled both parishes. He was supported in these points by both Graham Law and Gen Gidley. The Chairman expressed his concern also and requested details of the traffic statistics be sent to the Weaverham Parish Clerk so the matter could be further considered by the Parish Council.

- **61.** Approval of minutes of meeting of 18th July 2016 approved.
- 62. Matters arising from the minutes of the meeting of 18th July 2016 not dealt with elsewhere on this agenda
 - **62.1** Fineswim Ltd-the Chairman reported back on a meeting help with Fineswim Ltd regarding potential changes in future managerial arrangement for the pool.
 - **62.2** The Clerk reported a payment of £360 made to Nemisis Ltd in respect of VAT due.

63. Finance & Personnel Committee

- **20015/16** Annual Report. The reported that the 2015/16 Annual Return had been received following examination by the External Auditors. There were no matters to report. **The Council approved and accepted the 2015/16 Annual Return (including the External Audit certificate).**
- Extension of Mid Cheshire Grounds Maintenance Contract. Following a recommendation from the Environment Committee, the Council agreed to extend the grounds maintenance contract originally awarded to Mid Cheshire Grounds Maintenance Ltd by a further year i.e. to 31st March 2018 at the same rates and schedules of work as applied at 1st April 2012.
- 63.3 Approval of Christmas tree order. The Council approved an order to Nobletts Ltd for the purchase of Christmas trees in the sum of £404 plus delivery and installation of £225 (plus VAT). Clerk to check delivery costs.
- 63.4 Approval of Christmas tree lighting. The Council approved the purchase of two sets of white LED lights at an estimated sum of £570 each plus VAT) for the main Christmas tree. Further work to be undertaken regarding additional lighting and decorations.

64. Environment Committee

The Council noted a planned switch on date of Friday 25th November for the Christmas tree lights. The Council noted the proposals for additional signage for the swimming pool and **agreed that two new signs were sufficient-no need for car park signage. transfer of land document regarding land at Lime Avenue to Cheshire West & Chester Council. Clerk to action. Clerk was asked to arrange for an update of the Tree Survey following surgery work undertaken in April 2015. The Clerk reported that he had written to the owner of the former Doctor' surgery regarding an overgrown tree at the side of the building on surgery land. The Clerk confirmed that he will write to the portfolio holder for Highways at CW&C regarding the dangerous speeding currently being experienced along Gorstage Road.

POLICE REPORT TO WEAVERHAM PARISH COUNCIL 19th SEPTEMBER 2016 FROM SGT DAVIES-CHESHIRE POLICE

In the last 30 days, the police have recorded the following incidents:-

A male has been arrested, charged and remanded in custody for Possession with intent to Supply class A drugs. Others have been prosecuted for lesser offences out of the same incident.

Following complaints of speeding along Wallerscote Road, the police have requested highways to carry out maintenance to ensure the speed signage is correctly displayed. The hedgerow was almost completely obscuring the signage. The road is to be surveyed and if necessary, traffic enforcement will be carried out.
