Chapter One

My Wife and I have lived in this lovely village for the last 11 years but have visited for the last 40 years. The M.B5153 is the only B road in the United Kingdom to be bestowed with motorway status! High Street is part of this motorway.

When the survey was carried out to determine which roads in the village should be restricted to 20mph, the average speed was shown to be 33mph (1mph more and you can be fined for breaking the speed limit) I have stood with our local PCSO on two occasions while she carried out speed checks. She was at a terrible disadvantage due to being in full view of drivers wearing hi-vis and a large camera.

Another major concern is the chicane at Wheat Sheaf Public House, a few weeks ago while walking to the shops a single decker Orange Bus mounted the pavement missing me by inches. I believe this is also a concern to the council as I have seen a group of its representatives apparently discussing the situation.

Finally the zebra crossing close to the Smith's Lane junction is a waste of space as a number of drivers ignore its very existence. Many pedestrians prefer to cross at the junction with Forest Street these include unaccompanied school children some of whom (being fearless) step onto the road believing that vehicles will just stop allowing them to cross.

Over the recent weeks I have raised the issue of the misuse of Forest Street and the problem of safely accessing it by foot. This being with a cross section of Weaverham residents not just residents of Forest Street itself, not one person believes that the status quo should remain. Many of those spoken to refer to Forest Street as a RAT Run with both speed and weight limits being broken.

Safety issues relating to all road users and pedestrians:

- 1) restrict access to Forest Street from High Street to the 7.5t limit (which is an existing requirement but not enforced) Emergency Vehicles and Residents access only otherwise closed to through traffic. (7.5t limit would include the likes of Post Vans, Online Deliveries and Grocery Deliveries) The footpath would be carried through across the entrance forming a sleeping policeman. The double yellow lines on Forest Street being removed for the whole length up to the Fieldway junction, the top half of Forest Street remaining unchanged from Fern Way. New signage would be needed.
  - There would be only one exception to the above, that being access for the refuse vehicles.
- 2) The existing zebra crossing would then be moved to entrance of the Forest Street Junction. If zebra crossing it should have sparkly posts and brightly shining orange balls on top. Alternatively a Pelican could be used.
- 3) Finally from number 44 High Street to Withens Lane the speed limit be reduced from 30 to 20mph.



### Introduction

Residents have discussed perceived problems with traffic movements and traffic circulation on **High Street (HS) (B5153)** and **Forest Street (FS)**. Issues include footpath condition and widths, traffic volumes and speeds, road conditions including potholes. This overview focuses on Forest Street.

Below, the existing layout is described and possible options considered for variations in the layout to try to improve the road and environment for local residents.

### Perceived problem with existing situation

### **Existing Layout**

Existing deficiencies: The volume of traffic turning into Forest Street on High Street from both easterly traffic and westerly is relatively low, except in the early morning when FS is used as a rat-run to A49. However, the general running speed of traffic on these HS approaches to FS is problematic. Additionally, the road alignment of HS is substandard, with restricted geometry and forward visibility and because of the protected nature of the area these cannot be improved to current standards.

FS is a narrow one way street from HS through to LA junction, Fern Grove is a cul de sac off FS, it is two-way but with only left turn out onto FS, there are various properties off FS that have driveway access direct of FS. There is potential onstreet parking for 6 vehicles in front of the terraced properties at the northern extent with potential for 3 vehicles further south.

On FS the speed limit is 20mph through from HS to Lime Av (LA). Thereafter, it is 30mph on FS south and on LA it is 20mph in front of the school.

Traffic flow is generally low but numerous vehicles accessing FS from HS do accelerate very hard into FS at its northern end. This is most notable in the morning.

The 7.5t weight limit is often exceeded by HGV's delivering construction material etc:

### Possible Revisions to improve the traffic and environmental situation

### Option 1

### Reverse direction of traffic flow.

From the southern end of FS remove the no entry signs and markings but forbid entry to FS from HS. Keep all other features and configurations, change the regulations on Fern Close. Keep all other regulations, such as for the primary school, as is.

Exit on to **HS** will become problematic as the visibility to the right is restricted and during main traffic hours the volume is relatively higher and variable and would make this manoeuvre problematic with an inducement for school traffic to use this as a rat-run in the afternoon.

### Not Recommended

I agree it would most probably make matters far worse;



### Option 2

### Forest Street - Cul-de-sac

Configuring FS as a cul de sac with entry either at HS or LA. FS is predominantly of substandard width throughout its length. There is no space available for a satisfactory turning head resulting in conflict with other, local, road users. Service vehicles, refuse, delivery vehicles etc, would be presented with added problems. Through traffic would be removed. Turning manoeuvres problematic.

Problematic.

I agree it would most probably make matters far worse;

### Option 3

### Forest Street - Limited access for residents and service vehicles

Maintain the existing configuration of FS but with limitations such that access is restricted for "Residential Access and Service Vehicles only". All features would remain as similar to existing but the rat-run for school traffic and those who go on to A49 would be removed.

The regulations for signage could preclude this option and also the practicalities of it working as intended as the control to exclude traffic to **Fieldway** and **Longmeadow** would be problematic and would undoubtedly raise many objections. **Problematic** 

I agree that it is again problematic, Yet if the crossing were positioned as per my sketch (incidentally exactly where the Lollipop lady used to operate, a very fearless lady me thinks) it may make restricted access more viable. The crossing ideally would be the pelican type as near the junction with Withen's Lane;

### Option 4

Introduce a physical division in **FS** at a point just south of **FC**, with a throttle into **FS** south. This would give one-way (southbound) traffic on the northern section but two-way on the Southern section. There are only 4 private drive way accesses on this section all with multiple off-street parking, there is also the Childcare centre with 8 parking spaces with adequate turning space.

All traffic markings would need to be revised with special consideration for the school

Control of movement from the northern section into the southern section would be problematic until it becomes customary to the area. This will be a problem to regulatory authorities because of the one-off nature of the scheme and the possibility of misuse.


